Hodge City Park in Sopchoppy from 11:00 a.m. until the last boom from the dazzling fireworks display.

Setup will take place on Tuesday, July 3, 2018 (the day before event) between 3:00 p.m. – 5:00 p.m. that afternoon and Wednesday morning (the day of event) beginning at 8:00 a.m. All vendors must be set up and have all vehicles that are not used for the operation of their booth (limited to one) moved outside the festival grounds before the park opens at 11:00 a.m. Vendors will not be able to leave the park until after the fireworks.

Sopchoppy 4th of July Vendor Booth Application

11 a.m. to 10 p.m., Wednesday, July 4, 2018

Myron B. Hodge City Park, 252 Park Ave., Sopchoppy

- The Sopchoppy 4th of July Committee provides a 12' x 12' space for all vendors except food, which will be provided a 15'x15' space. If vendor set up is larger than the space provided, vendors must purchase additional space.
- Vendors must provide all necessary furnishings and equipment for their booths such as tables, chairs, and tents. If you require electricity, bring an extension cord of at least 75 feet; if water, bring a hose. Electric includes one double outlet (110V/30 amp) and water includes access of one hose bib.
- Items for sale and booth appearance must be appropriate for family audiences as determined by the Committee. Sale or possession of alcoholic beverages is prohibited.
- Food and concession vendors are the **only** vendors allowed to sell/distribute water & beverages.
- Food and concession vendors are solely responsible for their own licensing, liability insurance, and sanitation requirements. State inspectors regularly check vendor licensing at these events
- Booth locations will be assigned by the Committee. First enrolled **with payment** will receive noted preference in location. **In an effort to minimize competition, the Committee will limit the number of vendors selling the same type of food/concession items, so it is best to submit your application as early as possible.**
- All vendors agree to park their vehicles outside the festival grounds except for food and concession vendors who sell from their truck or trailer, which will be limited to one vehicle.
- **All applications must be received with payment no later than MONDAY, JUNE 25, 2018.**
- Sopchoppy 4th of July Celebration is a rain or shine event. **Fees are Non-refundable.**
